<b>WO or A or 1</b>	The good is wholly obtained in the Party of the Agreement
<b>PE or WP or B or 1 or WP (PE)</b>	The good is produced entirely in the Party exclusively from originating materials of the Party
<b>PS or PSR or C or 2</b>	The good is produced in the territory of one or both Parties, using non-originating materials that comply with the applicable product specific rule
<b>3</b>	The good is produced in the Party from originating materials of the Party or non-originating materials that comply with the applicable product specific rule
<b>RVC</b>	The good satisfies the requirement of a regional value content
<b>CTC</b>	All non-originating materials used in the production of the good have undergone a change at the first four digits in an HS Code
<b>QVC</b>	The goods meet the relevant qualifying value content rule
<b>CTSH +QVC 35 Build-up or CTSH+QVC 45 Build-down</b>	Non-originating materials have undergone at least a change in tariff sub-heading (CTSH) level of the HS code, AND the qualifying value content is not less than 35% of FOB value calculated by build-up formula OR 45% of FOB value as per build-down formula under IA-ECTA
